## Project status - overview

#### Since the webinar in **September**:

- Our product development team is continuously working on implementing NIAS-specific features in Labs
- We had **user interviews** with the **beta tester companies**, and finetuned the plans based on their **feedback**
- Registration is open, promotion of the platform started. Some Petcore Europe member companies
  are already registered, and we made progress with the onboarding of food contact testing laboratories
- Laboratory onboarding in progress and valuable comments received from the Laboratories




# Sign up for free









# **Order NIAS analysis**

- Use the NIAS order form to submit an order or choose from laboratory list directly
- Instant price calculation before sending the order
- Wait for confirmation from the laboratory
- Select to share results with Petcore before sending the order
- Only the data necessary to perform the analysis will be sent to the laboratories
- View orders, edit draft orders, or clone previous orders









### View results

# Data privacy

- If the customer selected to share the results with Petcore, then sample data, and results are shared in a separated Petcore data bank. Data bank is where the reports to DG SANTE reports are originated from.
- Certificate of analysis, and risk assessment only available to the customer
- Result numbers are by default also only visible to the customer who requested the analysis
- Within Petcore there are multiple access levels to the data bank



# Marketplace release plan – next steps

The initial version of the NIAS analysis in Labs will roll out the week of Nov 6.

The **presented features** will be available for all Petcore Europe members:

- ordering NIAS analysis, including migration assessments
- access to multiple laboratories, with real-time pricing
- repetitive ordering
- access to reports and certificate documents

Soft launch with beta testers including laboratories starts next week.

As of Tuesday, **18** users are already **registered** to the system from **8 different laboratories**, and we are in talks with much more, and plan to have a greater expansion in laboratory partners in 2024.

If you are working with a laboratory that is not part of this initiative, let them know, and we will help to bring them onboard, and go through the round robin test.





#### Introduction of Labs platform for Monitoring PET NIAS Accompany Letter

Working group NIAS of Petcore; Harmonized NIAS measurements - Offering Labs, KÖR's online platform for the PET value chain to harmonize compulsory measurements.

As Petcore Europe is representing already more than 170 members of the PET value chain, it has decided to create an online platform that offers supply and demand for harmonized NIAS measurements. The basis of the measurements was already set by the published guidelines for NIAS measurements' back in 2020. Trails of these measurements have been performed by taskforce which was presented on the Petcore Europe conference in 2023. The NIAS Working Group is responsible for organizing the introduction of this platform.

By the introduction of the new regulation for direct food contact applications EN 2022/1616, extra NIAS data are requested for the development of the novel technology but also for the monitoring of the suitable technology. The target of the platform is to create a harmonized concept which enables all members of the value chain to order PET NIAS measurements. The reports will be in a standard digital format which will facilitate the monitoring function of the various results in time. A special database function will be integrated which can be used to manage the monitoring function. As different reports and monitoring will be required 3 different Databases will be created individually have secured and limited access. These sub-platforms are the following:

- Functional Barrier Group (to facilitate the novel technology reporting to DG Sante and it's monitoring)
- Depolymerization Working Group (to facilitate the BHET reporting to DG Sante and it's monitoring)
- Geni Group (to facilitate the NIAS reports and monitoring of bottles and trays throughout the PET value chain)

For the demand of NIAS measurements all Petcore Europe members of these groups will be offered to contribute to use the Labs online platform.

For the supply of NIAS measurements, many laboratories are targeted to contribute to this platform as the required capacity and the today presented ones will require this. As the harmonization requires a validated level playing field, it is required that the different laboratories need to comply to base the monitoring of the results on a repeatable quality level. A proficiency test is required for the laboratories to secure the contribution of the results to this platform. We do understand that PET NIAS measurements can consist of targeted and non-targeted substances. The proficiency test will need to address both options to assure consistency in the results.


The Labs online platform is provided by KÖR (<a href="www.kor-group.com">www.kor-group.com</a>), a company that has been selected to tailor-made their existing and proven, cloud-based supply and demand solution to all Petcore Europe Members. They need to be able to order NIAS measurements at various laboratories. As KÖR is working in a 17065 ISO and in a 27001 ISO environment, specific requests are needed to build the functionality of the platform. As Petcore Europe we seek the support and cooperation of facilitating information and opportunities to help building this harmonized concept of supply and demand for NIAS measurements.








# Data flow and data privacy
